## Terms

Aal Yours, LLC will establish a market value and guide you in setting the start price on all consigned items. We will always strive to secure the best possible price for your item based on manufacturer, quality, condition and marketability of the piece.

- Items will be accepted for a 90-day consignment period, starting from day that they are priced and placed on the sales floor. Inventory will be reduced in price via a preset markdown schedule. There is a progressive price reduction of 25% every 30 days.
- If items are requested to be reclaimed prior to end of the consignment period, there will be a restocking fee of 30% of the starting price that is payable prior to the items being picked up.
- All consignment items must be clean, in displayable condition and ready for resale. Aal Yours, LLC may charge a fee up to \$25 if items require additional cleaning or repair. The cost of this work, if necessary, will be deducted from the consignor's portion of the proceeds from the sale.
- All items consigned with Aal Yours, LLC Unlimited, LLC remain the property of the consignor. While all reasonable efforts will be made to keep consigned items clean and safe from damage; Aal Yours, LLC is not responsible for LOSS or DAMAGE to consigned articles from fire, water, theft, damages or other casualty. Please ensure that you maintain appropriate insurance coverage.

## Unsold Items

Unless otherwise specified, items left in the shop 5 days after the consignment period ends will be donated (donation receipts available upon request) to a charitable organization or liquidated at the discretion of Aal Yours, LLC.

- Payouts are available for pickup in person at Aal Yours, LLC or used at any time for store credit; No cash settlements tendered.
